<u>Prescribed Minimum Qualification / Experience (in case of candidates not holding analogous post):</u>

1. Deputy Project Engineer (Civil):

Educational Qualifications: M.E./M. Tech in Civil with 55% marks.

Experience: Holding analogous post or having 8 years of experience as Assistant Project Engineer or an equivalent post in Govt./Semi-Govt./Public Sector/Autonomous organization or Educational Institution of higher learning in 7th CPC Level-10 or its equivalent.

Desirable: Experience in execution of construction and maintenance of large campuses.

Terms and conditions:

1. The post of Deputy Project Engineer (Çivil) is suitable for Physically Handicapped candidates with disabilities viz. Orthopedically Handicapped/Locomotor disability/Cerebral Palsy with One Leg Affected (Right or Left) (OL) and Hearing Impaired.

2. The candidate must be a citizen of India.

3. The post is on Deputation for a period of 5 years.

4. Candidates should apply through online mode only. Incomplete applications in any respect and application received physically shall not be considered.

5. Prescribed education qualifications and experience are the minimum eligibilities required and mere fact that a candidate possesses the same shall not entitle him/her for being called for an interview. The Institute reserves the right to restrict the no. of candidates admitted for interview to a reasonable number, on the basis of qualifications and/or experience.

6. <u>Selection of DPE (Civil) post will be through interview. However, Institute reserves the right</u> <u>conduct a written exam, if deemed necessary.</u>

7. All Candidates should obtain NOC from the present employer and upload the same online. However, application without NOC shall also be considered, provided the candidate uploads a duly signed undertaking that the NOC will be submitted at the time of Interview.

8. Applications should be submitted well in advance, without waiting for the last date.

9. Call letters to attend the interview will be sent only to the short-listed candidates by mail. Candidates are required to check their registered e-mail ID frequently. No correspondence will be made with applicants who are not short-listed/not called for interview.

10. The Institute reserves the right to reject any application without assigning any reason. The Institute also reserves the right to cancel the advertisement/ recruitment at any stage without assigning any reasons. No correspondence will be entertained in this regard.

11. Out station candidates called for interview will be paid railway fare in 2ndA/C from the place of duty/residence to Bengaluru and back by shortest route on production of original tickets.

12. The Institute reserves the right to verify the antecedents or documents submitted by the candidate at any time during the service. In case it is found that the documents submitted by the candidate are not genuine, then his/her services shall be terminated, and disciplinary/criminal proceedings will be initiated.
