In this context, IISc invites applications for the position of Technology Manager at its Intellectual Property and Technology Licensing office.

The appointment will be on a contract, initially for a period of one year, extendable for a maximum period of up to five years with an annual review for satisfactory performance. The base salary of **the Technology Manager** will be fixed in the range of Rs. 1,00,000 to 1,50,000 *per month* (consolidated). After an annual review by the IPTeL standing committee, an increment of 5% will be given on extension of contract. In addition, the manager will be paid 1% of net license revenue negotiated post joining and earned in a particular year, subject to a maximum capped at the yearly salary and paid out on an annual basis.

**Job Description:**

The manager's responsibilities will include the following:

- Evaluate patentability of disclosures submitted to IPTeL in conjunction with chair IP
- Oversee IP management and the IPTeL office management.
- Mine IP within IISc and market IISc IP to industries through suitable platforms
- Identify licensing opportunities and negotiate licensing agreements with industry
- Submit proposals to GOI on IISc's behalf to fund bridging of the TRL gap between current IP and industry needs.

**Eligibility:**

It is preferred that the candidate should at least have a

- Bachelor's degree in engineering or basic sciences or

**Experience:**

- 3 years of experience in IP and technology transfer management in industry, academia or government institutions
- a track record in licensing academic IP to industry will be given preference.

**Age:** Not exceeding 40 years as on 31.03.2020. Relaxation in age is applicable for the applicants from SC/ST/OBC and PH categories as per norms. Age can also be relaxed at the discretion of the Institute for the candidates with experience and merit.

**Mode of Selection:**

The selection of the candidates will be on the basis of their CV and performance in an interview conducted at the Indian Institute of Science, Bangalore.
