- * Quote should come only from Indian Original Equipment Manufacturer (OEM) or their Indian authorized distributor. The quotations should be on FOR-IISc Bangalore basis in INR only. Make-in-India policy of Govt. of India will be followed for this tender. Bids should be GTE compliant. Bids must contain a statement on the vendor's letterhead stating whether they are Class-I or Class-II local suppliers, as per the definitions below. Bids received without this statement will not be considered.

* With respect to this tender, the rules laid out by the Government of India in order No. P-45021/2/2017-PP (BE-II) issued by the Public Procurement Section, Department of Promotion of Industry and Internal Trade, Ministry of Commerce and Industry, dated 04th June 2020, will be followed. Per this order, only Class-I and Class-II local suppliers as defined below are eligible to participate in this open domestic tender. Non-local suppliers are ineligible to participate in this tender.

Relevant definitions as per Government of India order:

Class-I local supplier - a supplier or service provider, whose goods, services or works offered for procurement, has local content equal to or more than 50%

Class-II local supplier - a supplier or service provider, whose goods, services or works offered for procurement, has local content more than 20% but less than 50%.

Non-local supplier - a supplier or service provider, whose goods, services or works offered for procurement, has local content less than 20%.

Local content – the amount of value added in India which shall, unless otherwise prescribed by the Nodal Ministry, be the total value of the item procured (excluding net domestic indirect taxes) minus the value of imported content in the item (including all custom duties) as a proportion of the total value, in percent.
