## Prescribed Minimum Qualification / Experience:

**Educational Qualifications:** M.E./M. Tech in Civil Engineering with 55% marks.

**Experience**: 8 years of experience as APE or an equivalent post in Govt/Semi-Govt/Public Sector/Autonomous organisation or Educational Institution of higher learning in 7th CPC Level-10 or its equivalent.

**Desirable:** Experience in development or operation or maintenance of a modern academic or corporate or similar infrastructure. Familiarity with modern practices in civil constructions and electrical power systems.

Deputation can be considered from the officers from the Central/ State Governments or Institute of national importance or Universities/ University level institution or PSU holding analogous post, and possessing educational qualification and experience as prescribed above.

## Terms and conditions:

1. The post of Deputy Project Engineer (Civil) is suitable for Physically Handicapped candidates with disabilities viz. Orthopedically Handicapped/ Locomotor disability/Cerebral Palsy with One Leg Affected (Right or Left) (OL) and Hearing Impaired.

2. The candidate must be a citizen of India. Relaxation in age is applicable as per Govt. of India norms as applicable to the Institute.

3. The post is on Deputation /contract basis for a period of 5 years.

4. Candidates should apply through online mode only. Incomplete applications in any respect and application received physically shall not be considered.

5. Prescribed education qualifications and experience are the minimum eligibilities required and mere fact that a candidate possesses the same shall not entitle him/her for being called for an interview. The Institute reserves the right to restrict the no. of candidates admitted for interview to a reasonable number, on the basis of qualifications and/or experience.

6. Selection of DPE (Civil) post will be through interview. However, Institute reserves the right conduct a written exam, if deemed necessary.

7. All Candidates should obtain NOC from the present employer and upload the same online. However, application without NOC shall also be considered, provided the candidate uploads a duly signed undertaking that the NOC will be submitted at the time of Interview.

8. Applications should be submitted well in advance, without waiting for the last date.

9. Call letters to attend the interview will be sent only to the short-listed candidates by mail. Candidates are required to check their registered e-mail ID frequently. No correspondence will be made with applicants who are not short-listed/not called for interview.

12. Those who are joining the Institute service on or after 1st January 2004 are covered under the new pension scheme.
