A request for quotation from domestic (India-based) manufacturers for a Modular Q-Switched Nd: YAG laser. Quote should come only from Indian Original Equipment Manufacturer (OEM) or their Indian authorized distributor. The quotation should clearly indicate the terms of delivery, deliveryschedule, transportation charges (if any). The quotations should be on FOR-IISc Bangalorebasis in INR only.

With respect to this tender, the rules laid out by the Government of India in order No.P45021/2/2017-PP(BE-II) issued by the Public Procurement Section, Department of Promotion of Industry and Internal Trade, Ministry of Commerce and Industry, dated 4th June 2020, will be followed. Per this order, the government has defined a 'Class-I local supplier' as" a supplier or service provider, whose goods, services or works offered for procurement, haslocal content equal to or more than 50%". A 'Class-II local supplier' is "a supplier or service provider, whose goods, services or works offered for procurement, has local content morethan 20% but less than 50%". Only 'Class-II' local suppliers are eligible to participate in this open domestic tender. Any 'Non-local supplier', i.e., "a supplier or service provider, whose goods, services or works offered for procurement, has local content less than 20%" is ineligible to participate in this tender. Bidders offering imported products will fall under the category of non-local suppliers. They cannot claim themselves as Class-1 local suppliers/Class-2 local suppliers by claiming the services such as transportation, insurance, installation, commissioning, training, and other sales service support like AMC/CMC, etc., as local value addition.

Please enclose a compliance certificate along with the bid. This certificate should have a table that should describe your compliance in a "Yes" or "No" response against each of the items in the specifications listed below. If "No" is selected, the second column should state the extentof deviation. The third column should state the reasons for the deviation (if any). Section 2 – Eligibility Criteria

Prequalification criteria:

- 1. The Bidder's firm should have been in existence for a minimum of 3 years. (Enclose Company Registration Certificate)
- 2. The Bidder should belong to either class 1 or class 2 supplier distinguished by their "local content" as defined by recent edits to GFR. They should mention clearly which class they belong to in the cover letter.
 - (a) Class 1 supplier: Goods and services should have local content of equal to or more than 50%.
 - (b) Class 2 supplier: Goods and services should have local content of equal to or more than 20 % and less than 50%.
- 3. Purchase preference as defined by the recent edits to GFR (within the "margin of purchase preference") will be given to Class-1 supplier.
- 4. MSME can seek exemption to some qualification criteria. IISc follows GFR2017 for such details
- 5. The bidder should sign and submit the declaration for Acceptance of Terms and Conditions as per -Annexure 4.
- 6. The Bidder must not be blacklisted/banned/suspended or have a record of any service-related dispute with any organization in India or elsewhere. A declaration to this effect has to be given as per Annexure 3.

Section 3 – Terms and Conditions

A) Submission of Tender:

- 1. All documentations in the tender should be in English.
- 2. Tender should be submitted in two envelops (two bid system).
 - a. Technical Bid (Part-A) Technical bid consisting of all technical details and check list for conformance to technical specifications.

The technical proposal should contain a technical compliance table with 5 columns.

- i. The first column must list the technical requirements, in the order that they are given in the technical requirement below.
- ii. The second column should provide specifications of the instrument against the requirement. Please provide quantitative responses wherever possible.
- iii. The third column should describe your compliance with a "Yes" or "No" only. Ensure that the entries in column 2 and column 3 are consistent. Vendor must provide the detailed specifications in the compliance statement with respect to each technical specification in the tender document duly supported by the manufacturer's literature. Mere saying Yes to compliance sheet without supporting data, measurement will not be accepted.
- iv. The fourth column should state the reasons/explanations/context for deviations, if any.
- v. The fifth column can contain additional remarks from the OEM. You can use this opportunity to highlight technical features, qualify response of previous columns, or provide additional details, compare your solution with that of your competitors or provide details as requested in the technical requirements table below.
- b. Commercial Bid (Part-B) Indicating item wise price for the items mentioned in the technical bid, as per the format of quotation provided in tender, and other commercial terms and conditions.
- 3. The technical bid and price bid should each be placed in separate sealed covers, superscripting on both the envelopes the tender no. and the due date. Both these sealed covers are to be placed in a bigger cover which should also be sealed and duly superscripted with the Tender No, Tender Description & Due Date.
- 4. The SEALED COVER superscripting tender number / due date & should reach Chairperson Office, Department of Physics, Indian Institute of Science, Bangalore 560012, India on or before due date mentioned in the tender notice. In case due date happens to be holiday the tender will be accepted and opened on the next working day. If the quotation cover is not sealed, it will be rejected.
- 5. All queries are to be addressed to the person identified in "Section 1 Bid Schedule" of the tender notice.

- 6. GST/other taxes, levies etc., are to be indicated separately. The BIDDER should mention GST Registration and PAN in the tender document (Indian Bidders only).
- 7. Bidders offering imported products will fall under the category of non-local suppliers. They cannot claim themselves as Class-1 local suppliers/Class-2 local suppliers by claiming the services such as transportation, insurance, installation, commissioning, training, and other sales service support like AMC/CMC, etc., as local value addition.
- 8. Purchase preference as defined by the recent edits to GFR (within the "margin of purchase preference") will be given to the Class-1 supplier.
- 9. MSMEs can seek an exemption to some qualification criteria. IISc follows GFR2017 for such details.
- 10. If price is not quoted in Commercial Bid as per the format provided in tender document the bid is liable to be rejected.
- 11. The Institute reserves the right to accept or reject any bid and to annul the bidding process and reject all bids at any time prior to the award of contract, without there by incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders.
- 12. Incomplete bids will be summarily rejected.

B) Cancellation of Tender:

Notwithstanding anything specified in this tender document, IISc Bangalore, in its sole discretion, unconditionally and without having to assign any reason, reserves the rights:

- a. To accept OR reject lowest tender or any other tender or all the tenders.
- b. To accept any tender in full or in part.
- c. To reject the tender, offer not confirming to the tender terms.

C) Validity of the Offer:

The offer shall be valid 90 Days from the date of opening of the commercial bid.

D) Evaluation of Offer:

- 1. The technical bid (Part A) will be opened first and evaluated.
- Bidders meeting the required eligibility criteria as stated in Section 2 of this document shall only be considered for Commercial Bid (Part B) opening. Further, agencies not furnishing the documentary evidence as required will not be considered.

- 3. Domestic manufactures satisfying the technical specifications will be given priority.
- 4. Pre- qualification of the bidders shall not imply final acceptance of the Commercial Bid. The agency may be rejected at any point during technical evaluation or during commercial evaluation. The decision in regard to acceptance and / or rejection of any offer in part or full shall be the sole discretion of IISc Bangalore, and decision in this regard shall be binding on the bidders.
- 5. The award of contract will be subject to acceptance of the terms and conditions stated in this tender.
- 6. Any offer which deviates from the vital conditions (as illustrated below) of the tender is liable to be rejected:
 - a. Non-submission of complete offers.
 - b. Receipt of bids after due date and time and or by email / fax (unless specified otherwise).
 - c. Receipt of bids in open conditions.
- 7. In case any BIDDER is silent on any clauses mentioned in these tender documents, IISc Bangalore shall construe that the BIDDER had accepted the clauses as of the tender and no further claim will be entertained.
- 8. No revision in the terms and conditions quoted in the offer will be entertained after the last date and time fixed for receipt of tenders.
- Lowest bid will be calculated based on the total price of all items tendered for Basic
 equipment along with accessories selected for installation, operation, preprocessing and
 post processing, optional items, recommended spares, warranty, annual maintenance
 contract.

E) Pre-requisites:

The bidder will provide the prerequisite installation requirement of the equipment along with the technical bid.

F) Warranty:

The complete system is to be under warranty period of minimum 3 years (year wise breakup value should be shown in the commercial bid) including free supply of consumables, spare parts and data analysis software from the date of functional installation. If the instrument is found to be defective, it has to be replaced or rectified at the cost of the bidder within 30 days from the date of receipt of written communications from IISc, Bangalore. If there is any delay in replacement or rectification, the warranty period should be correspondingly extended.

G) Annual Maintenance Contract:

An annual maintenance contract for a period of at least 2 years post warranty should be provided on completion of warranty period.

H) Purchase Order:

- 1. The order will be placed on the bidder whose bid is accepted by IISc based on the terms & conditions mentioned in the tender document.
- 2. The quantity of the items in tender is only indicative. IISc, Bangalore reserves the right to increase /decrease the quantity of the items depending on the requirement.
- 3. If the quality of the product and service provided is not found satisfactory, IISc, Bangalore reserves the right to cancel or amend the contract.

I) Delivery, Installation and Training:

The bidder shall provide the lead time to delivery, installation and made functional at IISc, Bangalore from the date of receipt of purchase order. The system should be delivered, installed and made functional within 90 days from the date of receipt of purchase order. The supply of the items will be considered as effected only on satisfactory installation and inspection of the system and inspection of all the items and features/capabilities tested by the IISc, Bangalore. After successful installation and inspection, the date of taking over of entire system by the IISc, Bangalore shall be taken as the start of the warranty period. No partial shipment is allowed.

The bidder should also arrange for technical training of users if required.

J) Payment Terms:

100% payments (except AMC) will be released after completion delivery and satisfactory installation subject to TDS as per rules. AMC cost (if ordered), after completion of warranty period) will be released on half-yearly basis at the end of each six months subject to satisfactory services. The AMC will be comprehensive. Price basis must be on FOR-IISc Bangalore basis only. As per GFR no advance payment can be made to domestic vendors, unless an equal amount of bank guarantee is provided.

K) Statutory Variation:

Any statutory increase in the taxes and duties subsequent to bidder's offer, if it takes place within the original contractual delivery date, will be borne by IISc, Bangalore subject to the claim being supported by documentary evidence. However, if any decrease takes place the advantage will have to be passed on to IISc, Bangalore.

L) Disputes and Jurisdiction:

Any legal disputes arising out of any breach of contract pertaining to this tender shall be settled in the court of competent jurisdiction located within the city of Bangalore, India.

M) General:

- 1. All amendments, time extension, clarifications etc., within the period of submission of the tender will be communicated electronically. No extension in the bid due date/time shall be considered on account of delay in receipt of any document(s) by mail.
- 2. The bidder may furnish any additional information, which is necessary to establish capabilities to successfully complete the envisaged work. It is however, advised not to furnish superfluous information.
- 3. The bidder may visit the installation site before submission of tender, with prior intimation.
- 4. Any information furnished by the bidder found to be incorrect, either immediately or at a later date, would render the bidder liable to be debarred from tendering/taking up of work in IISc, Bangalore.

- 16. Power supply: 220VAC@50Hz, single phase power supply to control the laser is preferred
- 17. Cooling system: A self contained heat exchanger with air cooling preferred

Other terms and conditions:

- 18. It is mandatory to have an authorized dealer/supplier in India, necessary proof for the same should be provided with the technical bid
- 19. The Laser manufacturer should be from a reputed firm having wide range of systems in their portfolio and having all the models listed in their website including the quoted system.
- 20. The Laser should have 'Super Gaussian Resonator' configuration to provide diffraction limited beams with good quality in far field
- 21. The Laser should have the option for future upgrades including Harmonic generators and Energy attenuators. The Harmonic generators should be easily changeable modules which can be carried out by the end-user without any support from the technical engineer and without any requirement for any alignment of Optics and crystals
- 22. The supplier or the Indian agent should have factory trained service engineers in their team to provide prompt and efficient after sales service. Names and certificate copies of these engineers should be provided along with the Technical bid. This will be critical criteria in the selection of the offers.
- 23. A user list of existing users for similar systems should be provided along with the technical bid.
- 24. The system should have a warranty of 3 year from the date of installation.. The supplier should also mention the cost of 'Annual Maintenance Contract' per year after the standard warranty of the Laser in the commercial bid.
- 25. Installation Kit and Technical Manuals
- 26. Export packing

B. Spares and accessories

The supplier should also provide two Laser safety goggles with the system.
