2. **Job Profile/Responsibilities**

(a)	Supports the <i>effective</i> daily operation of the SAP system by using technical and functional knowledge and understanding of the Institute's business processes.
(b)	Performs detailed analysis of the Institute's business process requirements and provides appropriate system solutions; identifies, interprets, validates, and documents requirements.
(c)	Provides direction to SAP development teams for solution realization and participates, as necessary, during coding, testing, documentation, and maintenance activities.
(d)	(i) Design, customize, configure, and testing of FI/CO modules. (ii) Map the Institute's business requirements, processes, and objectives and develop necessary product modifications to satisfy the Institute's needs. (iii) Identify gaps and issues and work around solutions, (iv) System performance issues, (v) Implementation bugs, (vi) SAP best practices, (vii) Review the user Complaints and tickets
(e)	Participates in the System and User Acceptance Testing of the new developments, enhancements, and bug fixes in the respective SAP application modules
(f)	Trains and guides the SAP end users with the SAP functions, processes, workflows, and User Interfaces.
(g)	Develops and maintains documentation and may provide training related to the SAP Implementation, custom queries, reports, or other technology resources.
(h)	Work self-directed and independently; may act as subject matter mentor to more junior members.

3. Skills

(a)	Strong technical aptitude is required.
(b)	Over a period of six months, must be able to work independently, manage multiple concurrent tasks and work with people with differing technical knowledge levels.
(c)	Excellent oral presentation and written communication skills are required.
(d)	Must be detail-oriented.
(e)	Experience using word processing, spreadsheet, and other financial software is preferred.
(f)	Domain knowledge in respective areas is preferred.
(g)	Competency in the use of query and report tools is preferred.
(h)	Basic knowledge of ABAP will be preferred.
(i)	Hands-on experience with WRICEF objects.
(j)	Candidates with no experience in SAP need not apply.

4. Duration

Engagement is purely temporary on a contract basis, initially for a period of **one year** and renewable annually up to a maximum duration of **five years**, based on the satisfactory performance and requirements of the Institute. Contract tenure will commence from the date of joining. An increment up to a maximum of **10%** annually may be admissible in case of an extension of the contract, based on the performance of the candidate and the recommendation of the Chairperson of DIGITS.

The academic performance of the candidate (i.e., marks obtained), will be considered for shortlisting. Shortlisted candidates will be called for an online/in-person Interview.

	(e) If required, the electronic mode of interview (Zoom Call/ Microsoft Team) will be conducted and the same will be intimated to the candidates in advance. It is advised that the candidates should be prepared to give interviews in all the medium, if so required.
	(f) In case the interview is held in person, no TA/DA shall be paid for attending the interview.
	(g) Candidates may please ensure that they are fulfilling all the requisite criteria prior to registering, failing which, their candidature is liable to be rejected/cancelled.
