## Section 2: Eligibility Criteria

- 1. The Bidders firm should have existence of minimum of 5 years (enclose company registration certificate).
- 2. The Bidder must have received the accreditation from National Accreditation Board for Testing and Calibration Laboratories (NABL) in accordance with ISO 15189 based on ISO/IEC standard 17025 (enclose NABL certificate) and accreditation from College of American Pathologist (CAP) for genetic testing (enclose CAP Accreditation Certificate). The bidder should also have PCPNDT license for handling and processing of prenatal samples (enclose PCPNDT license certificate).
- 3. The Bidder should have a proven track record of variant interpretation and reporting on clinical samples and international publications for the same (enclose the list of publications). The bid may not be considered if the publication list is not enclosed.
- 4. The Bidder must submit an in-house lab facility certificate of Nanopore sequencing machine or proof of ordering and timeline for installation and validation.
- 5. The Bidder should sign and submit the declaration for Acceptance of Terms and Conditions as per Annexure 4.
- 6. The Bidder must not be blacklisted/banned/suspended or have a record of any service-related dispute with any organization in India or elsewhere. A declaration to this effect must be given as per Annexure 3.
- 7. The company must submit quotations / bid documents directly and act as Bidder.
- 8. The Bidder should belong to either Class-1 or Class-2 suppliers distinguished by their "local content" as defined by recent edits to GFR. They should mention clearly which class they belong to in the cover letter. a) Class-1 supplier: Goods and services should have local content of equal to or more than 50%. b) Class-2 supplier: Goods and services should have local content of equal to or more than 20 % and less than 50%.
- 9. Quote should come only from Indian Original Equipment Manufacturer (OEM) or their Indian authorized distributor.
- 10. Bidders offering imported products will fall under the category of non-local suppliers. They cannot claim themselves as Class-1 local suppliers/Class-2 local suppliers by claiming the services such as transportation, insurance, installation, commissioning, training, and other sales service support like AMC/CMC, etc., as local value addition.
- 11. Purchase preference as defined by the recent edits to GFR (within the "margin of purchase preference") will be given to the Class-1 supplier.

#### Section 3: Terms and Conditions

#### A. Submission of Tender

- 1. All documentations in the tender should be in English.
- 2. Tender should be submitted in two envelops (two bid system).
  - a. Technical Bid (Part-A) Technical bid consisting of all technical details and check list for conformance to technical specifications. The technical proposal should contain a technical compliance table with 3 columns.
    - i. The first column must list the technical requirements, in the order that they are given in the technical requirement below.
    - ii. The Second column should describe your compliance with a "Yes" or "No" only. Ensure that the entries in column 2 and column 3 are consistent.
    - iii. The third column may be used to add any comments. You can use this opportunity to highlight technical features, qualify response of previous columns, or provide additional details, or provide details as requested in the technical requirements table below.
  - b. Commercial Bid (Part-B) Indicating item wise price for the items mentioned in the technical bid, as per the format of quotation provided in tender, and other commercial terms and conditions.
  - c. The technical bid and price bid should each be placed in separate sealed covers, superscripting on both the envelopes the tender no. and the due date. Both these sealed covers are to be placed in a bigger cover which should also be sealed and duly superscripted with the Tender No, Tender Description & Due Date.
- 3. The SEALED COVER superscripting tender number / due date & should reach Chair Office, Department of Computational Data and Sciences, Indian Institute of Science, Bangalore 560012, India on or before due date mentioned in the tender notice. In case due date happens to be holiday the tender will be accepted and opened on the next working day. If the quotation cover is not sealed, it will be rejected.
- 4. All queries are to be addressed to the person identified in "Section 1 Bid Schedule" of the tender notice.
- 5. GST/other taxes, levies etc., are to be indicated separately. The BIDDER should mention GST Registration and PAN in the tender document.
- 6. If price is not quoted in Commercial Bid as per the format provided in tender document the bid is liable to be rejected.
- 7. The Institute reserves the right to accept or reject any bid and to annul the bidding process and reject all bids at any time prior to the award of contract, without there by incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders.
- 8. Incomplete bids will be summarily rejected.
- 9. The quotations should be on FOR-IISc Bangalore basis in INR only.

#### B. Cancellation of Tender:

Notwithstanding anything specified in this tender document, IISc Bangalore, in its sole discretion, unconditionally and without having to assign any reason, reserves the rights:

- a. To accept OR reject lowest tender or any other tender or all the tenders.
- b. To accept any tender in full or in part.
- c. To reject the tender, offer not confirming to the tender terms.

#### C. Validity of the Offer:

The offer shall be valid 180 Days from the date of opening of the commercial bid. The quoted price should be valid for two years following the signing of a Memorandum of Agreement with the IISc based on the quotation received.

#### D. Evaluation of Offer:

- 1. The technical bid (Part A) will be opened first and evaluated.
- 2. Bidders meeting the required eligibility criteria as stated in Section 2 of this document shall only be considered for Commercial Bid (Part B) opening. Further, agencies not furnishing the documentary evidence as required will not be considered.
- 3. Pre- qualification of the bidders shall not imply final acceptance of the Commercial Bid. The agency may be rejected at any point during technical evaluation or during commercial evaluation. The decision in regard to acceptance and / or rejection of any offer in part or full shall be the sole discretion of Purchase Committee IISc Bangalore, and the decision in this regard shall be binding on the bidders.
- 4. The award of contract will be subject to acceptance of the terms and conditions stated in this tender.
- 5. Any offer which deviates from the vital conditions (as illustrated below) of the tender is liable to be rejected:
  - a. Non-submission of complete offers.
  - b. Receipt of bids after due date and time and or by email / fax (unless specified otherwise).
  - c. Receipt of bids in open conditions.
- 6. In case any BIDDER is silent on any clauses mentioned in these tender documents, Purchase Committee IISc Bangalore shall construe that the BIDDER had accepted the clauses as of the tender and no further claim will be entertained.
- 7. No revision in the terms and conditions quoted in the offer will be entertained after the last date and time fixed for receipt of tenders.
- 8. Lowest bid will be calculated based on the total price of all items tendered.

## E. Purchase Order:

- 1. The order will be placed on the bidder whose bid is accepted by IISc based on the terms & conditions mentioned in the tender document.
- 2. The order will also be given only after the Memorandum of Agreement is signed by the Company and IISc.
- 3. The quantity of the items in tender is only indicative. Purchase Committee IISc, Bangalore reserves the right to increase /decrease the quantity of the items depending on the requirement. 4. If the quality of the product and service provided is not found satisfactory, Purchase Committee IISc, Bangalore reserves the right to cancel or amend the contract.

#### F. Delivery:

The bidder will abide by all the rules of this tender and the memorandum of understanding in term of conducting the and providing the results.

#### G. Payment Terms:

- 1. 100% payments will be released upon the receipt of an invoice for all the services in net 30 days.
- 2. The invoice will be subjected to TDS as per rules.
- 3. Price basis must be on FOR-IISc Bangalore basis only.
- 4. As per GFR no advance payment can be made to domestic vendors unless an equal amount of bank guarantee is provided.

#### H. Statutory Variation:

Any statutory increase in the taxes and duties subsequent to bidder's offer, if it takes place within the original

contractual delivery date, will be borne by IISc, Bangalore subject to the claim being supported by documentary evidence. However, if any decrease takes place the advantage will have to be passed on to IISc, Bangalore.

#### I. Disputes and Jurisdiction:

Any legal disputes arising out of any breach of contract pertaining to this tender shall be settled in the court of competent jurisdiction located within the city of Bangalore, India.

#### J. General:

- 1. All amendments, time extension, clarifications etc., within the period of submission of the tender will be communicated electronically. No extension in the bid due date/time shall be considered on account of delay in receipt of any document(s) by mail.
- 2. The bidder may furnish any additional information, which is necessary to establish capabilities to successfully complete the envisaged work. It is however, advised not to furnish superfluous information.
- 3. Any information furnished by the bidder found to be incorrect, either immediately or at a later date, would render the bidder liable to be debarred from tendering/taking up of work in IISc, Bangalore.

## **Section 4: Technical Requirements**

- 1. Whole-genome sequencing should be done using Long Read Sequencing Service on a Nanopore Sequencer. The number of samples range from 50 to 200.
- 2. 120-180 GB data per sample should be generated after Long Read sequencing using Nanopore PromethION flow cells (version R10.4.1 or later).
- 3. The total quality passed data generated after the sequencing should provide minimum coverage of 30X per sample, and minimum N50 8 kb for each sample.
- 4. High molecular weight DNA extraction protocol should be used. Extraction method should preserve long fragment lengths.
- 5. The generated data should adhere to standard quality control measures, DNA quality check should be done using Qubit Fluorometer, Agarose Gel Electrophoresis & Tape-Station.
- 6. The raw Nanopore sequencing data should be provided in BAM and FAST5/POD5 files.
- 7. Human samples for Nanopore sequencing should be provided by the bidder after due regulatory clearances as applicable based on the ICMR guidelines for biomedical research on human participants 2017. The samples must be from probands with a clinical indication that is very likely to be of genetic etiology. The samples should have been subjected to Whole Exome Sequencing (WES) on Illumina Novaseq 6000 or Novaseq X plus sequencers at minimum 80X coverage and should have failed to obtain a convincing diagnosis. The Whole Exome Sequencing raw data and (redacted) reports should also be provided by the bidder if needed.
- 8. Methylation information for the samples sequenced should also be provided as additional information if required. The methylation data can be shared in BAM file format upon request which can be analyzed in common alignment visualization tools. The file should contain both sequence and methylation calls.
- 9. The sequencing data should be provided within 5-6 weeks from the date of sample identification/collection.
- 10. Secure data transfer protocols should be utilized.
- 11. Data for whole exome and whole genome sequencing should be stored by the bidder and made available upon request for five years from the date of generation.
- 12. Data privacy regulations should be followed under the Information Technology (Reasonable Security Practices and Procedures and Sensitive Personal Data or Information) Rules, 2011.

#### 1. Investigations by Company Name:

- a. All the investigations and services will be provided by the Company as described in the technical specifications of the quote submitted by the Company to IISc as part of the request for quote (tender) titled "Long read sequencing of human clinical samples".
- b. Specifically, the Company agrees to provide the following deliverables to IISc:
  - 1. Human samples for Nanopore sequencing
  - 2. Whole-genome Nanopore sequencing data of the samples

## 2. Logistics by Company:

- a. The sample collection and sequencing services will be provided by the Company as required by IISc.
- b. The primary responsibility of collecting samples lies with the Company.
- c. The Company shall endeavour to send to IISc the sequencing data of the samples as per the schedule defined in the price list provided as part of the financial bid in response to the request for quote (tender) titled "Long read sequencing of human clinical samples". The Company shall not be responsible for delays due to circumstances beyond its reasonable control.
- d. Data sharing will be enabled by the Company at no cost, upon request by IISc.
- **3. Pricing at Company:** The Company shall charge IISc such amount as enumerated in the winning bid submitted in response to tender.
- **4. Billing by Company:** A monthly bill statement describing sample ID (as name volunteer/patient name may not be available), SID number, date of sample identification, date of Nanopore sequencing, date of data transfer to IISc, total charges, and net charges payable will be issued every month.
- **5.** Any discrepancy in the bill must be reported by IISc within 3 days of the receipt of the bill in writing at our email address only company email here. Delayed request will not be addressed.
- **6. Sampling by Company:** Samples are to be sent to the Laboratory of the Company as per the Sample procedures defined by Company as per all rules and regulations laid out by the state and central government authorities.

#### 7. Payment to Company:

- a. IISc shall make the payment against the invoice within 30 days from date of receipt. If the due amount exceeds the credit limit (60 days) sanctioned by us in the system, services will be automatically deactivated without prior information.
- b. If the services rendered by the Company are either not according to the standards prevailing in the industry, or if the Company renders deficient services, IISc is entitled to withhold payments to the Company until such deficiency is rectified by the Company.
