REQUEST FOR QUOTATION FOR DISPOSAL OF WASTE

Short Summary

The Indian Institute of Science is a premier research and academic institution of higher learning in the Country, having more than 500 faculty, 4000 students, and 1000 support staff in its sprawling campus of around 400 acres. The Institute also hosts many National/International Conferences, Workshops, Seminars, Symposia, and Training programs on its campus.

The Solid waste, including (i) wooden waste, (ii) metal, plastic & other waste, and (iii) construction debris generated at the Institute, must be disposed of as per the instructions given below.

Thus, IISc., Bangalore invites Indian agencies/vendors or their authorized Indian agencies/partners to submit a quotation for the disposal of said solid waste from the IISc campus.

Scope of work

There are three kinds of waste generated on the campus. These are as under:

1. Wood Waste
2. Metal, plastic, and other waste
3. Construction debris

The details of these three kinds of waste are given below:

1. Wood waste is scattered on the campus in many places. There are big wood logs as well as small branches, which are sacked in many places. This wood waste must be lifted from the present places, transported using the required machinery and manpower, and disposed of at the designated place (Jubilee Garden) on the campus. The agency/vendor must provide transportation and manpower for loading and unloading. The agency/vendor must also deploy machinery, if required, for loading and unloading purposes.
2. The metal, plastic, and other waste is also heaped in many places on the campus, which must be lifted, transported, and unloaded at the Scrap Yard of the Institute. The agency/vendor must provide transportation and manpower for loading and unloading.
3. The construction debris is also scattered in many places on the campus and identified. This must be lifted, transported, and disposed of outside of the campus as per the BBMP

norms. The agency shall be solely responsible for the disposal/recycling of waste outside the Indian Institute of Science premises conforming to the extant laws, and the institute shall not be liable or held responsible in this regard.

Terms and conditions:

1. The Agency must collect the above-mentioned waste as per the applicable laws prescribed by the Regulatory Authorities. All statutory norms must be followed.
2. Deploy only trained personnel, under effective supervision, to pick up, transport, and dispose of the solid waste as per the prevailing norms. The agency should provide all the necessary safety gear and equipment to undertake the waste disposal.
3. Ensure that the waste is not misplaced even in case of an accident on the road.
4. Obtain all additional licenses, permits, consents, sanctions, etc., as may be required or called for from/by local or any other authority for undertaking such work.
5. The Institute is not responsible for the disposal of construction debris outside of the IISc campus. The Agency should follow all norms.

Instructions for submission of quotation:

1. The agency must provide a quotation in the prescribed format, which is attached as Annexure-1.
2. Only construction debris is to be disposed of out of campus. All other waste must be disposed of within the campus (at designated places only).
3. The lowest one will be awarded the contract for the disposal of waste as deliberated in the scope of work.
4. The rates for the above-mentioned work must be quoted for lumpsum disposal only. The vendor/agency who wishes to submit the quotation may please visit the site before the quotation is submitted.
