Section 2: Eligibility Criteria

Prequalification criteria:

- 1. The Bidder's firm should have existed for a minimum of 3 years. (Enclose Company Registration Certificate)
- 2. The Bidder should belong to either class 1 or class 2 suppliers distinguished by their "local content" as defined by recent edits to GFR. They should mention clearly which class they belong to in the cover letter
 - a) Class 1 supplier: Goods and services should have local content of equal to or more than 50%.
 - b) Class 2 supplier: Goods and services should have local content of equal to or more than 20 % and less than 50%.
- 3. Purchase preference as defined by the recent edits to GFR (within the "margin of purchase

preference") will be given to the Class-1 supplier.

- 4. The bidder should sign and submit the declaration for Acceptance of Terms and Conditions as per -Annexure 4.
- 5. The Bidder must not be blacklisted/banned/suspended or have a record of any service- related dispute with any organization in India or elsewhere. A declaration to this effect has to be given as per Annexure 3.

Section 3 : Terms and Conditions

A) Submission of Tender:

- 1. All documentation in the tender should be in English.
- 2. Tender should be submitted in two envelopes (two bid system).
 - a. Technical Bid (Part-A) Technical bid consisting of all technical details and check list for conformance to technical specifications. The proposal should contain a compliance table with 4 columns in addition to the ones in the technical requirements table that has been included with this RFQ below. The compliance table should include all the items in the same order and format. The first column should describe your compliance in a "Yes" or "No" response. If "No" the second column should state the extent of deviation. The "third" column should state the reasons for the deviation if any. The fourth column can be used to compare your tool with that of your competitors or provide details as requested in the technical requirements table below. (suppliers who include any indication of prices in the technical bid will be automatically disqualified).
 - b. Commercial Bid (Part-B) Indicating item-wise price for the items mentioned in the technical bid, as per the format of quotation provided in the tender, and other commercial terms and conditions.
- 3. The technical proposal should contain a **technical compliance table with 4 columns.** The first column must list the technical requirements and other requirements, in the order that they are mentioned below. The second column should provide specifications of the instrument against the requirement (please provide quantitative responses wherever possible). The third column should describe your compliance with a "Yes" or "No" only. Ensure that the entries in column 2 and column 3 are consistent. The fourth column can contain additional remarks. You can use this opportunity to highlight technical features, qualify responses of previous columns, or provide additional details.
- 4. The technical bid and price bid should each be placed in separate sealed covers, superscripting on both the envelopes the tender no. and the due date. Both these sealed covers are to be placed in a bigger cover which should also be sealed and duly superscripted with the Tender No, Tender Description & Due Date.
- 5. The SEALED COVER superscribing tender number / due date, should reach The Convenor, Centre for Infectious diseases Research, Indian Institute of Science, C. V. Raman Avenue, Bengaluru 560012, on or before the due date mentioned in the tender notice. In case the due date happens to be holiday the tender will be accepted and opened on the next working day. If the quotation cover is not sealed, it will be rejected.
- All queries are to be addressed to the person identified in "Section 1 Bid Schedule" of the tender notice.
- 7. GST/other taxes, levies etc., are to be indicated separately. The BIDDER should mention GST Registration and PAN in the tender document (Indian Bidders only).
- 8. If the price is not quoted in the Commercial Bid as per the format provided in the tender document the bid is liable to be rejected.

- 9. The Institute reserves the right to accept or reject any bid and to annul the bidding process and reject all bids at any time prior to the award of contract, without there by incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders.
- 10. Incomplete bids will be summarily rejected.
- 11. The quote should come only from an Indian Original Equipment Manufacturer (OEM) or their Indian authorized distributor.
- 12. The quotations should be on FOR-IISc Bangalore basis in INR only.
- 13. Bidders offering imported products will fall under the category of non-local suppliers.

They cannot claim themselves as Class-1 local suppliers/Class-2 local suppliers by claiming services such as transportation, insurance, installation, commissioning, training, and other sales service support like AMC/CMC, etc., as local value addition.

- 14. MSMEs can seek an exemption to some qualification criteria. IISc follows GFR2017 for such details
- B) Cancellation of Tender:

Notwithstanding anything specified in this tender document, IISc Bangalore, in its sole discretion, unconditionally and without having to assign any reason, reserves the rights:

- a. To accept OR reject the lowest tender or any other tender or all the tenders.
- b. To accept any tender in full or in part.
- c. To reject the tender, offer not confirming to the tender terms.
- C) Validity of the Offer:

The offer shall be valid 90 Days from the date of opening of the commercial bid.

- D) Evaluation of Offer:
 - 1. The technical bid (Part A) will be opened first and evaluated.
 - Bidders meeting the required eligibility criteria as stated in Section 2 of this document shall only be considered for Commercial Bid (Part B) opening.
 Further, agencies not furnishing the documentary evidence as required will not be considered.
 - 3. Pre- qualification of the bidders shall not imply final acceptance of the Commercial Bid. The agency may be rejected at any point during technical evaluation or during commercial evaluation. The decision in regard to acceptance and / or rejection of any offer in part or full shall be the sole discretion of IISc Bangalore, and decision in this regard shall be binding on the bidders.
 - 4. The award of contract will be subject to acceptance of the terms and conditions stated in this tender.
 - 5. Any offer which deviates from the vital conditions (as illustrated below) of the tender is liable to be rejected:
 - a. Non-submission of complete offers.
 - b. Receipt of bids after due date and time and or by email / fax (unless specified otherwise).
 - c. Receipt of bids in open conditions.
 - 6. In case any BIDDER is silent on any clauses mentioned in these tender

documents, IISc Bangalore shall construe that the BIDDER had accepted the clauses as of the tender and no further claim will be entertained.

- 7. No revision in the terms and conditions quoted in the offer will be entertained after the last date and time fixed for receipt of tenders.
- 8. Lowest bid will be calculated based on the total price of all items tendered for Basic equipment along with accessories selected for installation, operation, preprocessing and post-processing, optional items, recommended spares, warranty, annual maintenance contract.
- E) Pre-requisites:

The bidder will provide the prerequisite installation requirement of the equipment along with the technical bid.

F) Warranty:

The complete system is to be under warranty period of minimum **3 years** including free supply of consumables, spare parts, and data analysis software from the date of functional installation. If the instrument is found to be defective, it has to be replaced or **rectified at the cost of the bidder within 10 days** from the date of receipt of written communications from IISc, Bangalore. If there is any delay in replacement or rectification, the warranty period should be correspondingly extended.

- G) Purchase Order:
 - 1. The order will be placed on the bidder whose bid is accepted by IISc based on the terms & conditions mentioned in the tender document.
 - 2. The quantity of the items in the tender is only indicative. IISc, Bangalore reserves the right to increase /decrease the quantity of the items depending on the requirement.
 - 3. If the quality of the product and service provided is not found satisfactory, IISc, Bangalore reserves the right to cancel or amend the contract.
- H) Delivery, Installation and Training:

The bidder shall provide the lead time to delivery, installation and made functional at IISc, Bangalore from the date of receipt of the purchase order. The system should be **delivered**, **installed**, **and made functional within 45 days (1.5 months) from the date of receipt of the purchase order**. The supply of the items will be considered as effected only on satisfactory installation and inspection of the system and inspection of all the items and features/capabilities tested by the IISc, Bangalore. After successful installation and inspection, the date of taking over of the entire system by the IISc, Bangalore shall be taken as the start of the warranty period. No partial shipment is allowed.

The bidder should also arrange for technical training for the local facility technologists and users.

I) Payment Terms:

The payment will be through bank transfer after successful delivery, installation and training.

J) Statutory Variation:

Any statutory increase in the taxes and duties subsequent to bidder's offer, if it takes place within the original contractual delivery date, will be borne by IISc, Bangalore subject to the claim being supported by documentary evidence. However, if any decrease takes place the advantage will have to be passed on to IISc, Bangalore.

K) Disputes and Jurisdiction:

Any legal disputes arising out of any breach of contract pertaining to this tender shall be settled in the court of competent jurisdiction located within the city of Bangalore, India.

- L) General:
 - All amendments, time extensions, clarifications etc., within the period of submission of the tender will be communicated electronically. No extension in the bid due date/time shall be considered on account of delay in receipt of any document(s) by mail.
 - 2. The bidder may furnish any additional information, which is necessary to establish capabilities to successfully complete the envisaged work. It is, however, advised not to furnish superfluous information.
 - 3. The bidder may visit the installation site before submission of the tender, with prior intimation.
 - 4. All imported equipment should be quoted in the currency of the country of origin, and all locally sourced items should be quoted in **Indian Rupees**.
 - 5. Any information furnished by the bidder found to be incorrect, either immediately or at a later date, would render the bidder liable to be debarred from tendering/taking up of work in IISc, Bangalore.
 - The selected vendor must register with IISc (free registration) if not already registered. As per the purchase policy, purchase orders can be raised only to registered vendors. Section 4: Technical Specifications

A) Wall mounted horizontal, rectangular, steam jacket two door Autoclaves, with radial locking and micro-PLC based temperature controller

- Chamber Capacity: 430,000 cc
- Chamber material of construction: Austenitic grade Stainless Steel comprising of 16-18% Chromium and 12-14% nickel.
- Chamber Thickness: 0.19"- 0.23"
- Chamber Design: Flat edged surface with smooth symmetric even corners to ensure no excess pressure on the corners.
- Chamber Accessibility: Front and Rear access made of austenitic grade stainless steel to ensure prevention of cross contamination with complete biological seal around the instrument.

- Access Mechanism: Shooting Bolts, evenly turned through radial center shaft supported via 3D designed hinge on one side for ease of rotation and lever mechanism to ensure proper sealing across the edges.
- Steam storage: steam chamber across on all sides of the autoclave chamber to ensure enough steam storage for the sterilization cycle. Made of Austenitic grade stainless steel of thickness 0.15" – 0.19"
- Steam Boiler: made of Austenitic grade stainless steel to ensure sufficient conversion of steam and then storing it into the steam storage.
- Heating Load: Energy Efficient power consumption of 18KW
- Working pressure: -0.1 mpa to 0.21 mpa
- Pressure creation: Via steam for positive pressure and vacuum system for negative pressure.
- Vacuum Mechanism: Via Vacuum pump of lubrication of liquid ring.
- Control: micro-PLC based temperature controller for the entire sterilization system backed by safety temperature overshoot preventer for the boiler and jacket. Pressure safety switch to be incorporated to ensure prevention of building excess pressure. Auto release of pressure from the chamber during emergency or on completion of the sterilization cycle.
- Data recording and logging on the recorder and online printing of the data of the sterilization cycle.
- Safety: Temperature overshoot protection, Pressure Overshoot protection, Excess
 Pressure Release mechanism. All Electrical components to be CE certified. Overall
 leakage current should be minimum or nil to prevent direct conduction of electricity into
 the equipment and prevent hazards. Heater protection mechanism to ensure prevention
 of heater damage and increase longevity.
- Manual observation of pressure monitoring mechanism to check the pressure built in the chamber, storage and boiler.

B) Accessories:

RO water purification system of 500L capacity connected to all the autoclaves for supply of water.

C) Training and demonstration:

Training in machine usage of the equipment must be demonstrated by the successful bidder at the bidder's cost to the end users at IISc, Bengaluru.
