# To whom it may concern

This is a **Request for quote (RFQ)** from **Indian Agencies** for <u>supply including Installation</u>, <u>Commissioning</u>, <u>training at site</u> for "IR Camera" at the "Department of Mechanical Engineering (ME), Indian Institute of Science, Bengaluru.

This Invitation for Bids is open to only domestic (India based) manufacturers, Indian OEM or its authorized Indian distributors. All interested vendors shall submit a response demonstrating their capabilities to produce the requested equipment to the primary point of contact listed below. With respect to this tender, the rules laid out by the Government of India in order No. P45021/2/2017-pp-BE-II issued by the Public Procurement Section, Department or Promotion of Industry and Internal Trade, Ministry of Commerce and Industry, dated 4th June 2020 will be followed.

## **General Terms and Conditions**

- 1. The bid should be submitted in the two-cover system, i.e., technical bid and commercial bid separately in sealed covers. The technical bid should contain all commercial terms and conditions, except the price.
- 2. The technical bid must contain a point-by-point technical compliance document. The technical proposal should contain a compliance table that should describe your compliance in a "yes" or "no" response against each of the items in the table listed in this RFQ. If "no" the second column should state, the extent of deviation. The third column should state the reason for the deviation, if any. The fourth column can be used to compare your tool with that of your competitors or provide details as requested in the technical requirement table below.
- 3. In the commercial bid, the price should be inclusive of all discounts.
- 4. The quotations should be on FOR-IISc Bangalore basis in INR only.
- 5. The vendor should have qualified technical service personnel for the equipment based in India (preferably in Bangalore). The Bidder should belong to either Class-1 or Class-2 suppliers distinguished by their "local content" as defined by recent edits to GFR. They should mention clearly which class they belong to in the cover letter. a) Class-1 supplier: Goods and services should have local content of equal to or more than 50%. b) Class-2 supplier: Goods and services should have local content of equal to or more than 20% and less than 50%.
- 6. The covering letter should clearly state that whether the vendor is a Class-II local supplier. Failing this the bid will be automatically rejected.
- 7. Any "Non-local supplier" i.e. "a supplier or service provider, whose goods, services or works offered for procurement, has local content less than 20%" is ineligible to participate in this tender.
- 8. Bidders offering imported products will fall under the category of non-local suppliers. They cannot claim themselves as Class-1 local suppliers/Class-2 local suppliers by claiming the services such as transportation, insurance, installation, commissioning, training, and other sales service support like AMC/CMC, etc., as local value addition.
- 9. Purchase preference as defined by the recent edits to GFR (within the "margin of purchase preference") will be given to the Class-1 supplier.

- 10. MSMEs can seek an exemption to some qualification criteria. IISc follows GFR2017 for such details.
- 11. The vendor to state the percentage of the local content and provide self-certification that the item offered meets the minimum local content requirement. They should also give details of the location(s) at which the local value addition is made.
- 12. The lead time for the delivery of the equipment should not be more than 3 months from the date of receipt of our purchase order. It should be clearly mentioned in the technical and commercial bids.
- 13. All the quotations must be valid for at least 90 days at the time of submission.
- 14. List of customers and references: <u>The Bidder should have supplied similar equipment</u> in Central Universities, preferably in centrally Funded Technical Institutes (IITs, IISC, IISER, NIT). Please provide the details and contact information.
- 15. The Bidder must not be blacklisted/banned/suspended or have a record of any service-related dispute with any organization in India or elsewhere. A declaration to this effect should be provided.
- 16. Items in addition to that listed in the technical table that you would like to bring to the attention of the committee, such as data sheets, technical plots etc. can be listed at the end of the compliance table.
- 17. Vendors are encouraged to highlight the advantage of their Laser optics and Delivery Head over comparable Laser optics and Delivery Head from the competitors.
- 18. If needed, a meeting for any technical clarifications can be scheduled with the undersigned by sending an email.
- 19. The Institute reserves the right to accept or reject any bid, or to annul the bidding process and reject all bids, at any time prior to the award of contract without thereby incurring any liability of the affected bidder or bidders.

The vendor must also be registered with GOVT. OF India and should have very good support network in India.
- 2. The Vendor should submit evidence of satisfactory performance in India of at least 05 (five) cooled infrared Thermography systems manufactured by the same OEM, during the last 2 years.
- 3. OEM (Original Equipment Manufacturer) must have office in India with calibration checking facility. Camera must be repairable in India.
- 4. The detector has to be supplied within 3 months from date of PO, failing which the order will be cancelled.
  - ♣ Should have proven record of successful installations within Indian education/research institutes. Proof of such installation must be enclosed.
  - The OEM/Supplier should have trained service engineers stationed in India for any on-site service requirement, details to be provided in the offer.
  - ♣ OEM/supplier should have requisite stock of necessary spare parts in India.

#### **TERMS AND CONDITIONS**

  - a. The Bidder/Vendor Must have supplied minimum 3 similar orders to reputed Government Organizations in INDIA in the past 3 years. Copies of Purchase Orders to be enclosed along with the Technical Bid as proof.
