**Duties & Responsibilities:**

The selected candidates are required to:

- (a) Assist the Security Officer in matters related to security and allied functions.
- (b) Maintain security-related documentation and records of the Security Department.
- (c) Discharge all other duties that may be assigned from time to time.
- (d) Work in shifts, including night shifts as assigned.

**Duration:**

Engagement is purely temporary on a contract basis, initially for a period of **one year** and renewable annually up to a maximum duration of **five years**, based on the satisfactory performance and requirements of the Institute. Contract tenure will commence from the date of joining. For candidates previously employed at IISc through appointments made by the HR Department, the duration of their prior service will be counted in the maximum permissible tenure of five years.

**Selection Procedure:**

The selection will be based on a Trade Test as well as a Physical Efficiency Test, which will be followed by an interview for the shortlisted candidates which will be conducted at the Institute on a date that will be notified later.

	(e) The selection process will be held in person, no TA/DA will be paid for attending the selection process.
	(f) Candidates may please ensure that they are fulfilling all the requisite criteria prior to registering, failing which, their candidature is liable to be rejected/cancelled.
